Agreement

I further understand that non-compliance with any of these rules is grounds for immediate dismissal without refund.

I understand that protective equipment cannot prevent all injuries a player might receive while participating in sports activities. In case of emergency, if I am not immediately available, I hereby authorize Player to be treated by Certified Emergency Personnel (i.e, EMT, First Responder, Emergency Room Physician, etc.)

I understand and agree that neither the Academy, the camp director, coaches, assistant coaches, instructors, helpers nor any others associated with Camps shall be liable for any injuries sustained by Player during Camp activities, and on behalf of myself, my family and Player, I hereby waive all rights to any claim for damages against the aforementioned persons and release them from any liability, including such as might arise from negligence. I further agree that any claim or dispute arising from or related to this agreement shall be settled by mediation and, if necessary, legally binding arbitration, in accordance with the *Rules* of the Institute for Christian Conciliation; judgment upon an arbitration award may be entered in any court otherwise having jurisdiction.

General Requirements

To participate in any activities associated with the Northside Baseball Academy 2008 Summer Baseball Camps, a player must meet all of the following requirements:

- Be at least 11 years old and no older than 18 years old on September 1, 2008
- Present a completed and signed Participation Agreement, Medical Release and Waiver of Liability (on reverse)
- Comply with Dress Code (described below)
- Comply with Code of Conduct (described below)
- Cooperate with coaches, helpers and other players in attendance
- Pay the required fees – Please make checks payable to: Northside Baseball Academy

Code of Dress / Appearance

All players must abide by the following at all functions:

- No jewelry
- No visible tattoos
- Hats must be worn correctly, with the bill in front (with the exception of catchers . . . while catching)
- No language or graphics on any clothing that depicts alcohol, drugs, tobacco, violence, sexual innuendo, profanity, mysticism, the occult, gangs, etc.

In addition, players should have appropriate clothing for each of the camps, including:

Ultimate Baseball Camp – baseball pants and hat, cleats AND tennis shoes, and appropriate protective gear
Strength & Conditioning Camp – shorts and t-shirt

Code of Conduct

All players, coaches, parents and others must abide by the following code of conduct when attending or participating in any Northside Baseball Academy activity:

- No profanity, abusive language or belittling of other players, coaches, etc.
- No illegal drugs or alcoholic beverages allowed
- No drunken or disorderly behavior
- No suggestive or offensive language, innuendo, gestures or jokes.

In addition, the camp director has the authority to set additional rules of conduct that must be adhered to. If you have a problem with any attitude or action (including those of your own son), please address your comments and/or suggestions to the camp director either in person, by email (info@northsidebaseball.net) or by phone at 936-756-2292. If, after being warned, a player continues to exhibit inappropriate behavior, as designated above, player will be excused from the camp and no refund shall be provided.
